Drug and Alcohol Monitoring and Information System (DAMIS)

Activity report

October 2014 - March 2015

Background

DAMIS is an "early warning system" designed to find out about emerging trends in drug and alcohol misuse, so we can act quickly and provide relevant information or advice to those who misuse drugs or alcohol.

The kind of information DAMIS collects includes:

- 1. A sudden increase in a particular drug being misused
- 2. Drugs being misused in new ways
- 3. New drugs becoming available
- 4. Emergence of substances with unexpected unpleasant or dangerous effects

The DHSSPS oversee DAMIS with support from the lead partners: the Public Health Agency, the Department of Justice and the Police Service of Northern Ireland.

As at April 2015, DAMIS has an email circulation list of 285 individuals. Unless otherwise stated, information sent out by DAMIS is emailed to all those on the list. People can be added to this list by emailing a request to damis@hscni.net.

<u>Information circulated by DAMIS during October 2014 – March 2015</u>

In the majority of the above cases, more information was sought either from the original informant, or from other experts in the field (Addictions staff, Homeless staff and drug users) and DAMIS partners continue to monitor the situation. In some cases, information was sent to specific groups, for example GP Practices, or Needle Exchange Providers.

In some cases, information was considered to be of sufficient urgency for it to be circulated to the full DAMIS database. Information circulated to the full DAMIS database is shown in the table below:

Additional awareness raising

In addition to the DAMIS alert on botulism on 2nd January, the Chief Medical Officer issued a CMO Alert to key medical staff http://www.dhsspsni.gov.uk/hss-md-1-2015.pdf

Reports of UPS logo ecstasy pills containing very high levels of MDMA, along with a number of PSNI seizures of such tablets, were considered of sufficient urgency for the Public Health Agency to issue a press release on this topic on 12th February.

The PHA is in ongoing discussions with partners around the potential need for further awareness raising around synthetic cannabinoids.
